Which is **not** a body corporate or a multinational or a sale tax registered manufacturing concern or a sale tax registered business concern having annual turnover of less than Rs. 50 million.

➤ Application must be signed by a Director in the case of a Company and a Partner in the case of Partnership firm.

➤ Authorized Representative is mandatory.

➤ Incomplete membership form will be rejected
